MAQUOKETA CITY COUNCIL MEETING Monday, August 16, 2021

Mayor Schwenker called the regular session of the Maquoketa City Council to order at 6:00 p.m. with six members present.

Motion by Collister, seconded by Woodward approving the consent agenda consisting of the agenda, August 2nd minutes, bills, Hinson Consulting invoice in the amount of \$3,638.10 for City Manager search, renewal class "C" liquor license, outdoor sales and Sunday sales filed by Timber Lanes Bowling Company, Inc., Mt. Hope Cemetery request for \$15,000 budgeted donation and authorize payment in the amount of \$4,565.00 to police department for employee uniforms.

Motion Carried 6-0

Smith reported that she received six applications for the building inspector position and narrowed it down to two with various strengths. The Personnel Committee recommends hiring Brad Koranda as the full-time inspector and Scott Wirth as the part-time seasonal inspector.

Good questioned if either applicant had a license for lead safety or asbestos. Smith reported that ECIA has it now and Simonson reported there would be training for this.

Woodward questioned the need for a full-time and part-time employee and Collister reported the City currently employs a full-time and part-time person.

Holme asked if anyone had any thoughts about Mr. Olep's comments. Collister stated he had already talked to Mr. Olep and Schwenker stated the same.

Collister stated he feels Koranda and Wirth are the best candidates and they can be certified in whatever the City needs.

Motion by Lyon, seconded by seconded by Collister to hire Brad Koranda as full-time building inspector effective January 1, 2022 and Scott Wirth as part-time seasonal inspector effective August 16, 2021. Motion Carried 5-1 Nay: Good
