Mayor Messerli called the regular session of the Maquoketa City Council to order at 6:07 p.m. with six members present.

Mayor Messerli stated the resolution to approve the State of Iowa Community Development Block Grant Coronavirus (CDBG-CV) Procurement Policy and the resolution approving the subrecipient agreement for 2022 CDBG-CV Grant with Innovate 120 should be removed from the consent agenda.

Motion by Collister, seconded by Kuhlman approving the consent agenda consisting of the agenda, June 6, 2022 regular minutes, bills in the amount of \$1,378,691.28, May financial reports, Mayoral appointment of Brenda Klemme and Joelle Hosette to the Historic Preservation Commission, Cigarette Permit filed by KJ's Convenience and Deli, solid waste collector application filed by BFI Waste Services, LLC, new class "E" liquor license and Sunday sales filed by Main Street Tobacco, authorizing a reimbursement payment to City Manager, Joshua Boldt, for employment transitional expenses in the amount of \$5,000 per City Manager contract Section 15-5.
