MAQUOKETA CITY COUNCIL MEETING Monday, October 2, 2023

Mayor Messerli called the regular session of the Maquoketa City Council to order at 6:00 p.m. with six members present:

The group recited the pledge of allegiance.

Boldt reported that the developer of Meadow Park Subdivision is required to provide the City with a four-year maintenance bond as part of the development agreement. The developer expects to have this by later in the week. Boldt is recommending Council amend the resolution on the agenda to be contingent on receipt of the maintenance bond.

Motion by Collister, seconded by Lyon approving the agenda as amended with item 10L.

Nicole Hutchcroft was discussed the quarterly Chamber report updating Council on the Star Spangled Freedom event, Chamber Golf Outing and Teacher Luncheon. The Chamber has hired Linda Tenney and they will be planning It's a Wonderful Life.

Motion by Collister, seconded by Rickerl approving the consent agenda consisting of September 18th minutes, bills payable through October 2nd, renewal class "B" retail alcohol filed by Kwik Star #212 and renew class "C" retail alcohol license filed by Jackson County Far Association.

Boldt reported that Change Order #15 for the Platt Street Project is the final change order that includes redesign or Arcade Street for ADA compliance and push button pedestrian lights.

Motion by Collister, seconded by Lyon approving Resolution No. 2023-109, entitled, "Resolution authorizing publication of notice and date of meeting to consider proposed revenue purpose statement for franchise fees."

Motion Carried 6-0

Boldt reported that Council must pass a revenue purpose statement stating the franchise fees will be used for 60% property tax relief and 40% Street Improvements.

Boldt reported that Thompson Truck & Trailer has pushed back the delivery of the City's new dump truck. Because of the new date, the City is now purchasing a 2025 model instead of 2024 but there is an additional cost of \$13,431.

Motion by Kuhlman, seconded by Rickerl approving Resolution No. 2023-117, entitled, "Resolution authorizing purchase of a vertical screen screw from OR-TEC in the amount of \$23,165." Motion Carried 6-0
Motion by Collister, seconded by Lyon approving Resolution No. 2023-118, entitled, "Resolutio declaring items as surplus equipment and authorizing sale." Motion Carried 6-0
Motion by Lyon, seconded by Rickerl authorizing payment to Bernie's Heating & Cooling in the amount of \$16,097 for Library HVAC services. Motion Carried 6-0
Motion by Collister, seconded by Holm to go in to closed session under Iowa Code 21.5(1)(c) fo potential litigation. Motion Carried 6-0
