

MAQUOKETA CITY COUNCIL MEETING

Monday, January 15, 2024

Mayor Messerli called the regular session of the Maquoketa City Council to order at 6:00 p.m. with seven members present.

Present: Simonson, Rickerl, Lyon, Collister, Kuhlman, Ehlinger, Bennett

The group recited the pledge of allegiance.

Motion by Collister, seconded by Kuhlman approving the agenda.

Motion Carried 7-0

Mayor Messerli gave his state of the City address. He reported on the WWTP Project, Prairie Creek Project and the Platt Street Project. He discussed upcoming plans for Park upgrades and equipment for the police department. He encouraged citizens to contact elected officials with problems.

Mayor Messerli opened the public hearing regarding the adoption of the proposed City Code of Ordinance. There were no written comments. Boldt explained the City has contracted with Simmering Cory to update the book and host the code on line. Motion by Lyon, seconded by Rickerl closing the public hearing.

Motion by Collister, seconded by Bennett approving the consent agenda consisting January 2nd minutes, bills in the amount of \$1,560,690.40, December financial reports and new cigarette permit filed by Punky's Cans 2 Cash LLC.

Boldt reported the City share of the change order is \$1,194.

Motion by Lyon, seconded by Collister approving Resolution No. 2024-5, entitled, "Resolution approving transfer of \$234,430 payable out of the American Rescue Plan Act fund for the purpose of City of Maquoketa revenue loss replacement."
