Project: 2022-2023 Tree Maintenance

<u>General</u>: The City of Maquoketa is requesting sealed competitive bids for a variety of tree and stump removals throughout the City. There may be one bid awarded for bid items #1 thru #24 and one bid awarded for bid items #25-29. Depending on the bid results each section may be awarded separately. The different tree and stump removals are dependent on location and the work being done.

<u>License</u>: Successful bidder must have a Current Tree Trimmers' License with the City of Maquoketa.

<u>Tree Trimming/Removal – Specifications:</u>

- 1. The bidder will contact all utilities that have overhead utility lines in the vicinity of the trees to be removed or trimmed. The bidder will make the necessary arrangements with the employees of the utilities in order to ensure that no utility lines are damaged.
- 2. The bidder will contact Iowa One Call at 1-800-292-8989 to have all utility lines located before beginning any work.
- 3. The bidder will furnish and use barricades to warn pedestrians and automobiles in areas where they will be working. The bidder shall not close any street without first giving at least a 48-hour notice to and gaining the approval of the police chief and public works director. Maquoketa public works department will **NOT** provide assistance with traffic control. **TYPE III BARRICADES** must be used to close off the block where the work is taking place along with orange cones. The street where the work is taking place will be closed during the tree removal operation.
- 4. The bidder will only work on those trees that have been marked for removal or trimming. Trees scheduled for removal will be numbered with white paint on the tree unless otherwise noted. Trees will be marked by 3:00 p.m. on **Monday, September 19, 2022**.
- 5. ** Due to the current state of these (6) trees, they will need to be removed first. The bold and ** locations on the bid sheet indicate these priority trees. These (6) priority trees will have a removal completion date of Wednesday, November 30, 2022.
- Bidder will be responsible for all clean up and removal of all wood and debris to a privatelyowned and properly zoned location. CLEAN UP OF WOOD AND DEBRIS MUST BE COMPLETED AT THE END OF EACH DAY.

- 7. Bidders with questions should call City Hall (652-2484) and City Staff will contact the public works director.
 - 8. The bidder will be held responsible for any property damage caused by their work.

Stump Removal – Specifications:

- 1. Bid price is to include removal of stumps to a depth no less than six (6) inches below grade. The contractor will be responsible for removing all grindings and debris from the hole of the removed stump. The City will be responsible for back filling the holes of the removed stumps.
- 2. If the adjoining sidewalk must be removed to perform the tree removal/stump grinding operation, please contact public works beforehand so arrangements can be made to remove the sidewalk.

<u>Insurance</u>: During the term of the project, the Contractor shall maintain, at their sole expense, the following insurance policies. Even if the City has an insurance certification on file, all bids <u>MUST</u> be accompanied with a copy of:

<u>Bids due:</u> Bids must be completed and received at City Hall prior to <u>Friday, October 7 at 11:00 a.m.</u> Sealed bids marked "Tree Maintenance 2022-2023" are to be dropped off or sent to the City of Maquoketa, 201 East Pleasant Street, Maquoketa, Iowa 52060. The City reserves the right to reject all quotes, either all or in part, waive informalities and select the bid that best suits its application. The City Council may award the bid at the council meeting on Monday, October 17, 2022. A notice to proceed will be mailed to successful bidder. Work can begin upon notice to proceed.

Completion of Work: All work must be completed no later Friday, March 17, 2023.

I will notify City Hall, the Maquoketa Police Department and The Public Works Department prior to beginning any of the tree removal process and will use Type III Barricades to close off the street.

I hereby certify that the bids submitted are for a "not-to-exceed" amount and include all cost for labor, insurance, and all incidental costs. I further certify that I have inspected each of the trees and stumps listed on the attached bid sheet.

I certify that I understand and will abide by all of the terms and conditions enumerated in the City of Maquoketa, Iowa Tree "Maintenance Program 2022-2023" document herein.
