7. Discussion and possible motion recommending Street Improvement Services bid to River City Paving in the amount of \$481,713.86

<u>City Manager Summary</u>: The next three items are post July 1, 2024 payment items but work may actually begin anytime in May-June 2024. The goal of this item is an affirmative motion to recommend a contract to City Council. This time of the year is the common period in which competitive bidding is popular and yields the best results for the City. PW Director, Frank Ellenz, and Confidential Secretary, Jan Ketelsen, worked very hard on recruiting bids and compiling all data for PW Committee consideration.

8. Discussion and possible motion recommending Crack Sealing Services bid to Manatts in the amount of \$79,590

<u>City Manager Summary</u>: Similar to item 7, the goal of this item is to recommend a contract to City Council. This was for crack filling/sealing services to prevent water intrusion and weed line growth at the curb lips.

This bid set covers the following:

- Crack Filling/Sealing:
 - Curb lip route & seal 7500 linear feet
 - o W/D 3405 sealant 8250 linear feet
 - ½" to 1" gap cleaning & sealing 8250 linear feet
 - o Rout & crack seal on sealcoat streets 33000 linear feet

The goal of this item is to prepare streets for the anticipated sealcoats on item 9.

9. Discussion and possible motion recommending Seal Coating Services bid to Corrective Asphalt Materials in the amount of \$60,537.60

<u>City Manager Summary</u>: The last street related contract consideration is for the seal coating. Again, the goal of this discussion is to recommend a City Council contract. This is a single bid because the product specified is proprietary. The bidder is <u>Corrective Asphalt Materials</u>. CAM met with Frank Ellenz and consulted on the desires of Maquoketa's plans and acted as a fiduciary by advising what their products would be good on versus what streets are too far degraded. Thus with their help, Frank Ellez formulated several recommendations to preserve street life in the City in combination with the efforts in item 8 and their own 18" curb lip milling during summer seasons.

Management reference checked CAM with the City of Des Moines and DeKalb County, IL Highway Department reference CAM's performance and recommendations given our City street conditions.
